In planning for Australia's clean energy future, RES acknowledges its rich history. We pay our respects to the Auburn Hawkwood People Aboriginal Coporation and the Wakka Wakka Native Title Aboriginal Corporation as the Registered Native Title Body Corporates of the Country on which the Tarong West Wind Farm is proposed.

Project Summary

The Tarong West Wind Farm (the Project) is located within the South Burnett Regional Council local government area approximately 30 kilometres (km) west of Kingaroy and 8 km north-west of Kumbia.

The wind farm, comprising up to 97 turbines, will deliver significant local benefits within the proposed Southern Queensland Renewable Energy Zone (Southern QREZ), through local employment opportunities and community benefit programs.

Project Update - August 2024 Community Consultative Committee (CCC)

The Project Team are in the process of appointing an Independent Chairperson for the proposed CCC. Once appointed, applicants for the CCC will be contacted to enable the final confirmation of the committee.

The first CCC meeting is scheduled to take place in Q4 2024. Once the Committee is finalised, Terms of Reference for the CCC will be made available on the Tarong West Wind Farm website.

Background Noise Monitoring

Thank you to those who have registered interest for further pre-construction background noise monitoring at properties neighbouring the Project. The Project team is appointing a consultant to undertake the monitoring in late 2024 and will provide further information directly to interested property owners.

Development Approval

Following last month's announcement that the Development Application has been approved, RES is continuing to work through post-approval requirements, including management plans and ongoing engagement with regulatory bodies including South Burnett Regional Council. We are continuing to work with Council on project related topics including determining the most suitable transport routes and overall traffic safety. A copy of the Decision Notice from SARA is available on the Project Website under the Resources tab.

EPBC Process

We will be holding further information sessions for the Project in the coming months. Further details will be shared when available.

Sponsorships

RES have set up a community sponsorship scheme during the development phase of the Project, ahead of the future Shared Benefit Scheme that will be established from construction commencement.


