Project Summary

The Tarong West Wind Farm (the Project) is located within the South Burnett Regional Council local government area approximately 30 kilometres (km) west of Kingaroy and 8 km north-west of Kumbia.

If developed, the 97 turbine wind farm will deliver significant local benefits within the proposed Southern Queensland Renewable Energy Zone (Southern QREZ), through local employment opportunities and community benefit programs.

Project Update - June 2024

Community Consultative Committee (CCC)

We are establishing a Community Consultative Committee (CCC) who will be involved with the project team in decision making processes throughout project development and construction. The CCC is proposed to include up to 5 members of the local community, 1 representative of Local Council, up to 2 representatives of the Project and an independently appointed Chairperson. The CCC is expected to be finalised in the coming months.

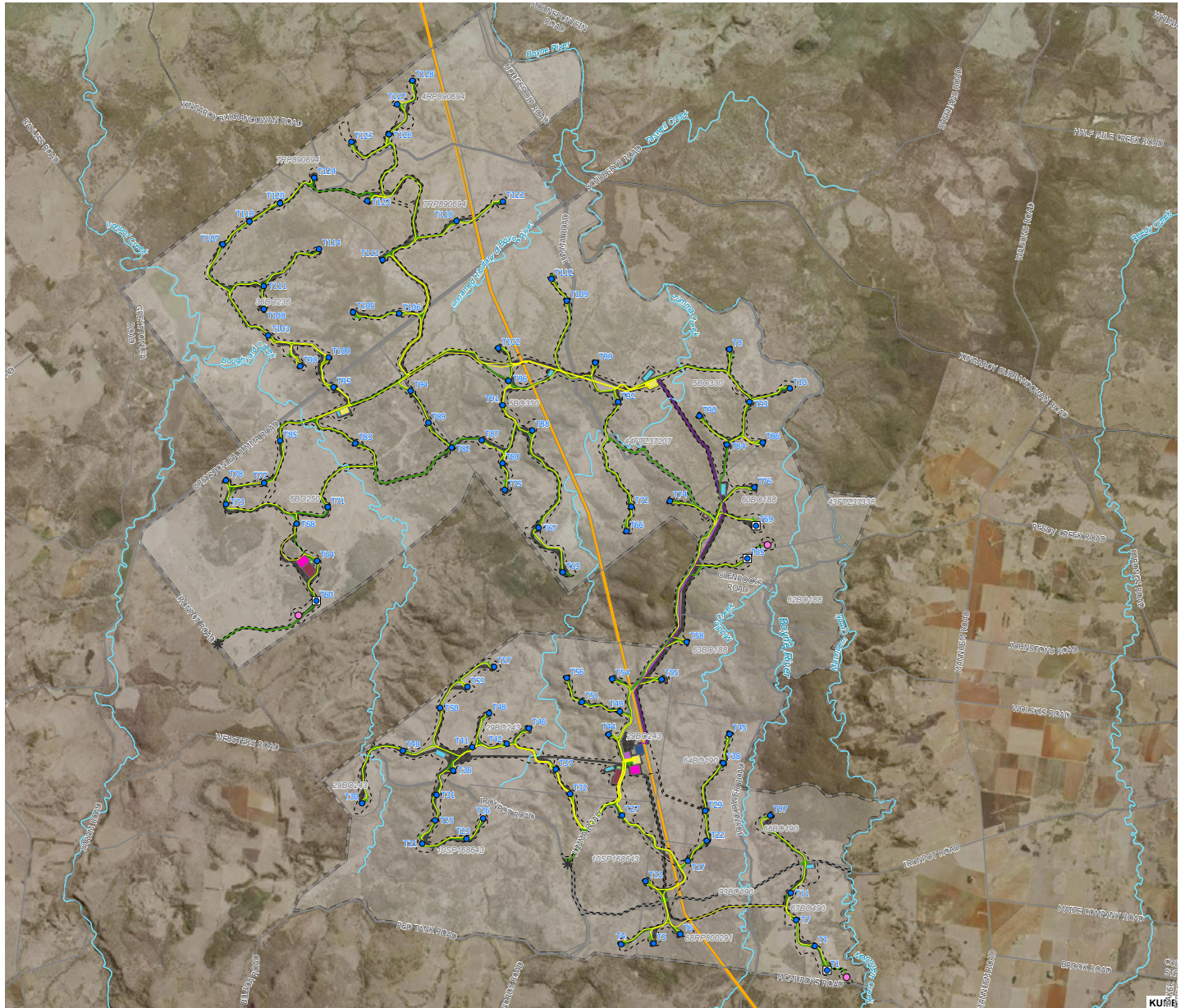
Development Application and EPBC

The Development Application assessment by the Queensland State Government State Assessment and Referral Agency (SARA) is ongoing.

RES is also drafting a Public Environment Report for Tarong West Wind Farm's EPBC Assessment by the Federal Government. RES is aiming to submit the Public Environment Report in July 2024.
